As responsible of processing your Personal Information, in compliance with the FEDERAL LAW ON THE PROTECTION OF PERSONAL DATA HELD BY PRIVATE PARTIES this Privacy Notice explains the type of treatment we give to the personal data that we collect, how it is used and with whom we share with. In accordance with article 16 of the law, we inform you of the following:

What personal information do we collect from you?

As a user / applicant / client through this means we will only collect the following data:

- Your name, address, date of birth
- Your email and phone number.
- Information that we obtain from you when you enter our page, that is, your interests, related topics, articles of interest, links, etc.

What do we use your personal data for?
